To Become SFI Compliant, Required Core Classes Include:

- ◆ Phase I and II Professional Timber Cutter Training
- ◆ Skidder Training
- ◆ Introduction to SFI (impacts of harvesting, environmental regulations)
- ◆ BMP (Best Management Practices)
- ◆ First Aid/CPR

Continuing Education Classes:

- ◆ Eight hours per year of continuing education required to maintain SFI compliant status.

Training On Your Site:

If you would like to hold training sessions on your site, please contact Ashley Tandy at the IHLA office, 317-875-3656. The following requirements must be met to hold an on-site training class.

Cutter - \$900.00 minimum, plus \$100 for each additional person over 9. Maximum number of trainees is 12. Harvesting work site required.

Skidder - \$900.00 Maximum number of trainees is 9. Harvesting work site and skidder required.

SFI - \$25.00 per person. Required minimum to hold class is 10. Classroom type facility for up to 10 people

BMP - \$25.00 per person. No minimum requirement. A recently harvested work site and facility large enough to hold 1/2 day classroom training required.
